Whether you own, rent or are visiting a unit in Sorrento, welcome!

Sorrento is made up of 152 units contained in 38 fourplex carriage homes. Unit owners are responsible for the interior upkeep of their unit, and all 152 owners share the costs of upkeep of everything else -- the exterior of the buildings, streets, landscaping, pool, clubhouse, gym, etc.

Sorrento is a condominium association governed by a volunteer Board of Directors (BOD), five in number, elected annually by the owners. The BOD is assisted by various committees comprised of volunteer owners. The BOD oversees the operations and finances of the Association with an annual budget approved by the owners. As required by law, Sorrento funds reserves for future capital expenses. The BOD is also responsible for compliance with Sorrento's governing documents, which can be found on the community's website, <u>www.sorrentocondo.com</u>. **PLEASE REVIEW THESE DOCUMENTS, as they are binding on owners, tenants, guests, and invitees.**

Sorrento's finances are managed by the CPA firm Myers Brettholtz, (239) 939-5775. Owners are encouraged to arrange for automatic payment of regular quarterly assessments.

Entrance Gate Access:

Details will be shared when it becomes operational.
